Row over freedom fighters called 'terrorists' in Bengal university paper

VC blames 'printing mistake'

PASCHIM MEDINIPUR (WB)

After controversy erupted in West Bengal after a question in an undergraduate history examination paper set by Vidyasagar University referred to Indian freedom fighters as "terrorists". Vice-Chancellor of the University, Dipak Kumar Kar, referred to it as "a printing

"A printing mistake occurred in the question paper of the undergraduate history examination yesterday... I enquired about the matter with the Controller of Examinations and asked for a report from the Controller of the Examination as well as from the Chairperson of the Undergraduate Board of Studies of History. that the error occurred during moderation, which was unintentional and not detected during proofreading, also," Kar said.

'We have decided that the concerned teacher who

was involved in the moderation will be replaced by a new member, and the Chairman of the Board of Studies will also be exempted from his chairmanship," he added.

West Bengal Assembly Suvendu Adhikari in a post on X described the terrorist reference as "absolutely outrageous." "The administrative authorities of Vidyasagar University have once again insulted our revered freedom fighters by labeling the brave revolutionaries of Medinipur as 'militants' and 'terrorists' in the 2025 History Honours sixth semester question

paper," he said.

This is not an isolated mistake but a deliberate distortion of our history, repeating the same disgraceful error from 2023 under the watch of Dr. Nirmal Kumar Mahato, Head of the History Department and a known TMC affiliate in WBCUPA (West Bengal Board and University Professors Association); TMC's political organisation comprising professors," Adhikari added.

TMC state general secretary Kunal Ghosh distanced the party from the controversy, saying, "The questions were set by a few persons, not the education department. It needs to be investigated who approved the question paper.' CPI(M) leader Sujan Chakraborty and Congress' Adhir Ranjan Chowdhury also condemned the terminology, calling it "unthinkable

unimaginable in independent India" and held the TMC government accountable for allowing such a lapse under its watch.

BJP ploy to steal election through backdoor: Rahul

BHUBANESWAR

Congress leader Rahul Gandhi on Friday accused the BJP of making attempts to "steal (chori) the upcoming elec-

tions in Bihar, as it did in Ma-

harashtra" last year. The Congress leader also accused the Election Commission of India (ECI) of not doing its duty but working for the interest of the BJP.

Addressing the party's 'Samvidhan Bachao Samavesh (Save Constitution rally)' here, the leader of the opposition in the Lok Sabha also said the INDIA bloc, of which Congress is a part, decided to prevent the BJP from stealing the

Bihar assembly polls.

The Congress has been alleging that the manipulation of the voters' list helped a BJPled alliance win the Maharashtra assembly polls in 2024. "Like Maharashtra, attempts are being made to steal the elections in Bihar. The BJP is attacking our Constitution across the country. At a meeting yesterday, the INDIA bloc decided to prevent the BJP and ECI from stealing the elections in Bihar," Gandhi said.

The assembly polls in Bihar are due later this year.

"A Maharashtra like conspiracy is underway in Bihar to manipulate election outcomes. We wanted to know

how one crore voters were added to the list ahead of the Maharashtra elections. But the ECI has no reply," Gandhi said. The BJP runs the government for five to six capitalists and not the common people of the country, he alleged.

"Nowhere in the Constitution, it is written that the country belongs to Adani, Ambani or billionaires only, but the present government is doing everything for 5-6 capitalists at the cost of common people," Gandhi said.

Alleging that Lord Jagannath's Rath Yatra in Puri was halted for Adani and his family, the Congress leader claimed that Odisha has become a model for them.

Row over Rai textbook glorifying **Cong PMs**

The Rajasthan government has dropped a text book of XII standard allegedly glorifying the Congress Prime Ministers. The decision has triggered a political controversy as opposition Congress has termed it RSS-driven "ideological attack" on the state's education system

The BJP ruled government of the state has not only decided to withdraw the text book Azadi Ke Baad Swarnim Bharat Parts 1 and 2 but removed the senior assistant director of the Board of Secondary Education Rajasthan as well in connection with the publication of this book.

About 4.90 lakh copies of the book have been printed and around 80 percent reportedly distributed in 19700 schools, but now have become scrap as Education Minister Madan Dilawar announced to drop it, alleging that the books, introduced during the previous Congress government, unfairly glorify Congress leaders, including those responsible for the Emergency, while neglecting key national figures.

TMC leader shot dead in WB

Kolkata: A TMC leader was shot dead by unidentified people in the South 24 Parganas district of West Bengal, the police said on Friday. The deceased was identified as Rajjak Khan, a resident of Chak Maricha village of Chaltaberia Gram Panchayat in South 24 Parganas district.

The incident took place in Bhangar on Thursday night when Khan, a close associate of TMC's Canning Purba MLA Saokat Molla, was shot by unidentified gunmen.

"An initial probe revealed that three bullets hit the deceased," a senior officer from Kashipur Police Station told PTI.
